

1. What is your MOQ(min. order quantity) for **Kids/Baby Play Mat** ?

MOQ is 500m²/design. For example, it is 250pcs if the size is in 100x200cm.

2. What's the standard size for a Kids Rug?

The width exactly divided by 400cm is fine, there are no material waste, such as 40cm, 44.5cm, 50cm, 57cm,66.5cm, 80cm, 100cm, 133cm,200cm, 400cm.

3.What format of the design needed?

JPG, PDF, AI, PCX, are fine.

4. How many colors can be produced in one design?

- 1) For chromojet printed, Normally within 12 colors inclusive of white color;
- 2) For digital printed, there is no limited.

5. How to choose design colors?

Pantone colors (Pantone C, Pantone U, Pantone TPX) are acceptable, If exact colors cannot be appointed, our professional design team will recommend the best match color for verification and approval.
